The full impacts of COVID-19 are still unknown and evidence will continue to be analysed as it arises. For example, the number of people unemployed which becomes evident after furlough finishes, the financial failure of some businesses, inability of citizens to pay council tax / rent, increased levels of homelessness and related increased levels of children living in poverty. All of these would have an adverse impact onto equality and create financial pressure on the Council's General Fund and Housing services.

It was not possible for the 2021/22 budget setting process, in part due to additional work caused by the pandemic, to undertake detailed engagement and consultation with the public on the Council's plans and budgets but members have agreed a process and timetable for this to be done for the 2022/23 budget process.

### **Impact**

Continued investment in early years expansion, schools and Angus Health and Social Care partnership and social work services is expected to have a positive impact across all age groups with the Angus area.

The budget proposes deferring a planned further reduction in teacher numbers at this time so that the impact of previous reductions may be more fully evaluated. Only a partial evaluation was possible for session 2020-21 due to periods of school closure and remote learning. The planned further reduction will also be considered in the context of our 'recovery plan' as we continue to respond to necessary restrictions due to COVID-19.

Investment in the redesign of the Children with Disabilities team which will expand capacity and enable a greater focus on the coordination and support of respite services will have a positive impact. This expansion will ensure that all children with disability cases can be handled by a dedicated team which is expected have a positive impact on the child and their families / carers.

The review of Public transport in the change programme will potentially have a positive impact on people with disabilities as it aims to make the transport system more accessible.

Some of the proposals that form part of the Council's budget for 2021/22 contribute to the achievement of statutory requirements to reduce the poverty / socio-economic attainment gap for children and young people. These include:

- A commitment to fund a programme of provision during school holidays which includes food and fun
- The investment in additional capacity for our Children, Families and Justice Service will increase the support available for those children and young people who are most disadvantaged
- The uplift in fees and allowances paid to kinship and other carers contributes to reducing poverty among the families of looked after children and young people.
- Key services offering support such as Welfare Rights have had resources retained at existing levels (protected from reductions in funding)

## Step 13(A) What evidence do you have about any socio-economic disadvantage/inequalities of outcome in relation to this strategic issue?

Analysis informing the Angus Local Outcomes Improvement Plan and Council Plan indicates that child poverty and women's inequalities are issues for Angus Council to address. Health inequalities continue to present challenges for our older population, as well as those with disabilities albeit these are mainly addressed by the Angus Health & Social Care Partnership. We know that some communities in Arbroath experience challenges associated with deprivation although there are pockets of deprivation throughout Angus. This is particularly associated with inequality in these communities around income, employment and health. Assessment work on the impact of the COVID-19 pandemic on these existing inequalities will be required.

Ongoing engagement mainly through the Council's Communities Teams is being undertaken with groups and communities to understand the nature of the socioeconomic impact arising from the proposals and any mitigating actions that may be available.

#### **Impact**

Continued support for free school meals/hardship payments and digital inclusion with access to IT equipment for school children who would otherwise not have been able to learn at home is being made. A Council Tax freeze for 2021/22 if implemented will have a positive impact on low and no wealth households along with the continued suspension of car parking in Angus and the Council has made adequate provision in its budget to support those households eligible for Council Tax Reduction Scheme support. The budget also provides funding for Scottish Welfare Fund payments and Discretionary Housing Payments.

**Material Deprivation** (i.e. those unable to access basic goods and services e.g. repair/replace broken electrical goods, warm home, leisure and hobbies).

#### **Impact**

Angus Council continues to provide support to ANGUSalive, who have been significantly impacted by COVID-19 throughout 2020/21 and will continue to be so for much of 2021/22. This financial support will allow leisure facilities to welcome back all residents of Angus and continue to provide subsidised services including fitness and exercises classes and facilities, once safe to do so.

Some aspects of the Council's budget for 2021/22 may have a negative impact on material deprivation for those households with limited digital connectivity because the Council continues to move to more digital service provision. However, the Council knows digital approaches don't work for all and will continue to provide services in non-digital ways for those citizens who require this.

The budget provides funding for Scottish Welfare Fund payments including grants to allow basic goods to be provided as well as for financial and/or support in kind by our Social Work Services.

The Council expects to utilise additional funding from Scottish Government for food and financial insecurity during 2021/22 in response to the pandemic and the budget will ensure all such funds are directed to their intended purpose.

#### **Impact**

The Council continues to invest in IT development in rural areas and also continues to provide public transport to these areas. COVID 19 impact on working from home and home schooling has seen funding from the Scottish Government for increased digital inclusion and safe use of school transport when and where necessary. This has had a positive impact on area deprivation.

**Socio-economic Background** i.e. social class including parents' education, people's employment and income.

### **Impact**

The aspect of the budget setting proposals which will have the most significant impact on people who already experience socioeconomic disadvantage will be the related elements of the Council's Change Programme. This programme continues to focus on efficiency and minimising impact on front line services and has been impacted by COVID-19, delaying some of the projects from 2020/21 into 2021/22. It does include some reduction in services or changes to how they are provided. It is likely that a small number of these proposals will have a negative impact on those families and people with a socio-economic background but most of the budgets these groups rely on are being protected and in some cases enhanced through additional investment.

The Scottish Government continues to channel grants through Local Government to be paid over to business and the self-employed in the area which will have a positive impact in the longer term allowing more businesses to continue to operate in the future.

Additional investment in Tay City Deal will have a positive impact on the area and increase investment and employment opportunities.

The officers named below consider that due regard has been paid by Angus Council to the impact onto inequalities of outcome caused by socio-economic disadvantage, when setting the 2021/22 Budget and Council Tax. It is highlighted that positive mitigating action is being undertaken in a number of areas to assist those who are experiencing socioeconomic disadvantage. It is however important to stress the financial context the Council is operating in which is one of ongoing and severe financial constraint over many years now as evidenced by the £66.1m which has had to be saved in the last 8 years. The Council's ability to address socio-economic disadvantage is constrained to a significant extent by the funding it has available and the multitude of other statutory duties it is required to meet.
