COVID-19 FUNDING - DISCRETIONARY FUNDING PROJECT APPROVALS

REPORT BY IAN LORIMER, DIRECTOR OF FINANCE

ABSTRACT

This report seeks member agreement to use Scottish Government COVID-19 funding provided to the Council to help support local people and communities where the Council has a degree of discretion over the use of the funding.

1. **RECOMMENDATIONS**

It is recommended that the Council:

- (i) approve the proposed use of COVID-19 funding where the Council is able to use the funding with a degree of discretion as set out in this report and Appendix 1;
- (ii) note the additional allocation of £34,000 to Schools Direct Payments as set out in Appendix 2.

2. ALIGNMENT TO THE COUNCIL PLAN

- 2.1 This report contributes to the following strategic priorities in the Angus Council Plan, we want:
 - To maximize inclusion and reduce inequalities
 - Our communities to be strong, resilient and led by citizens
- 2.2 In light of the COVID-19 pandemic we have looked again at our priorities to best support our people and our businesses in Angus to recover and renew over the short, medium and longer term. We have looked at our response to COVID-19, the strong partnerships developed, the pace at which we responded and how we adapted our ways of working to support our citizens.
- 2.3 As will be evident from this report's contents the Council and Third Sector Partners continue to be on the front line in providing support to people in response to the pandemic and these support actions will contribute to many of the priorities and ambitions in the Council Plan.

3. BACKGROUND

- 3.1 Angus Council is in receipt of several Scottish Government grants in relation to COVID-19. Most of these grants are for a set purpose with specific requirements in place, while others are offered with a degree of flexibility and discretion on how their core purposes can be delivered.
- 3.2 To ensure that the funding provided to the Council to support local communities (where there is discretionary over how to deliver that support) is being spent/allocated in ways that will address need Expressions of Interest (EOI's) have been sought from Council services and Third Sector Partners using the funding and criteria provided by Scottish Government.

Criteria and Objectives cover:

- COVID-19 Response
- COVID-19 Recovery
- Working in Partnership

- 3.3 Funding requests must directly relate to needs that have occurred as a result of COVID-19. Applicants are asked to clearly define the need in their EOI. This can be:
 - A 'new need' that did not previously exist, or was not known to exist prior to COVID-19
 - An 'existing need' that was known to exist prior to COVID-19, but there is additionality as a direct result of COVID-19
- 3.4 Applications for funding are assessed in line with objectives of the Scottish Government Strategic Framework and the Angus Council Plan.
- 3.5 Reference is made to Report 328/20 considered by the Council at its meeting of 17 December 2020 and to Report 333/20 to the same Council meeting and to Report No 137/21 to the Angus Council meeting of 13 May 2021 all of which gave further background on the range of grants being provided and how these would be managed through a mixture of delegated authority and seeking prior member approval. This report covers the use of funding which although intended by the Scottish Government to help Councils provide support to local communities involves discretion and choice on how the Council does that.
- 3.6 Responding to the pandemic continues to be a huge challenge and this report therefore seeks member agreement to use some of the Government COVID-19 funding provided to the Council where the Council is able to use the funding on a discretionary basis.

4. CURRENT POSITION

- 4.1 At the present time the Council currently has one funding stream provided to enable COVID related support to local communities on a discretionary basis. Angus has received a Flexible Fund allocation of £653,000. The Council has also received funding to support the administration of COVID support grants.
- 4.2 The First Minister announced the £15m Flexible Fund for local authorities on 17 November 2020, to enable local authorities to strengthen their support for people and communities impacted by level 4 restrictions. This funding was to cover spend up to 31 March 2021 including administration and delivery costs.
- 4.3 The Scottish Government wrote again to Local Authorities on 2 March 2021 to advise that an additional £15 million had been allocated to the Flexible Fund and, to amend and broaden the purpose to strengthen local authority responses to meet emerging needs and support people in their communities struggling with the restrictions and guidance at all protection levels, particularly those at higher risk through health and social inequalities.
- 4.4 It was agreed between Scottish Government and COSLA to combine the original £15m and additional £15m and provide £30m of funding through the Local Government finance settlement, paying the whole amount as a redetermination of the General Revenue Grant (GRG) for 2020-21 with no follow up reporting requirements. This approach to funding provides flexibility on the timing of any spend.

5. PROPOSALS

- 5.1 Details of the individual projects for which formal approval is sought are contained in Appendix 1 in this report. The Grants Assessment Panel and Grants Sub-Group of officers views were sought regarding the proposed projects and the responses are noted in Appendix 1.
- 5.2 Details of an additional allocation for Schools Direct Payments for noting are contained in Appendix 2 in this report. The Grants Assessment Panel and Grants Sub Group of officers views were sought regarding the request and the responses noted in Appendix 2.
- 5.3 Further reports will be presented to Council/Committee, if and when further project approvals are required during the financial year.

6. FINANCIAL IMPLICATIONS

- 6.1 The financial impact of the proposals in Appendices 1 and 2 is covered in full by additional government funding provided to the Council as COVID-19 funding for specific schemes the Government has asked Councils to deliver.
- 6.2 A summary of the financial implications are outlined below if the Council are minded to agree all the proposed projects.
