1. **Welcome and apologies**: The Chair welcomed all those present to the virtual meeting of the community council and hoped everyone was keeping well and safe.

- 2. **Minutes of Previous Meeting:** Minutes from last meeting approved by Julia Smith and seconded by Stevie Bell
- 3. Matters Arising from previous meeting: None
- 4. Correspondence: All correspondence received was related to planning applications and road maintenance
- 5. Local CouncillorReports:

Cllr Brenda Durno - Dealt with Arbroath harbour issues concerning boat maintenance, waste management issues of some boat owners, safety lights not working, unauthorized personnel using facilities for boat owners. Discussions taking place on the markers at the signal tower slip being removed as in the dark yachts are misleaded to thinking this is harbour entrance. All these concerns have been sent to the harbour master and should be discussed at the next harbour meeting.

Clir Lois Speed – Dealing with constituent matters and the issues concerning the bollards at the train station. Network rail is a statutory body and are not required to apply for consent for any. Further talks about relocating the bus shelter and increasing the number of dropped kerbs for individuals with physical and mental impairments are ongoing. Angus roll out of vaccines is going very well with 65% of adults in Angus having received their first dose and 12.7% have received their second dose. All care home staff and residents have received both doses as of the date of this meeting. Garage lockups in Cairnie area and the accumulation of rubbish will be cleared shortly, issue concerning asbestos within it is delaying this as expert advice is received on how to remove this safely.

School Counselling Service - available in schools for children over 10 years old however children under 10 can be referred or advised of children's referral to mental health support and pathway. Ongoing work is underway in Angus to improve services with increased funding to third sector organisations, wellbeing workers in every GP surgery and public participation opportunities. A 7 day a week service is being rolled out within Arbroath planned for later this year/next (2021/22)

Question received regarding the message of one medical practice of 'if you are phoning concerning the vaccine, please hang up' and that the message should be providing information on how and where to access information relating to this instead. **ACTION - Councillor Speed will take this forward and report back at the next meeting.**

Clir Derek Wann - Dealing with constituent issues, such as housing and COVID grants for businesses. Complaints recently regarding litter at parks and beaches and on the back of this month's police report, requested that the bin situation at Victoria Park is looked into again. After a constituent complaint and my own observations a 20mph zone will be introduced at rear of High School/MacDonald Park on Lochlands Drive to make this safer for all.

Discussed with Ian Wren his Dog mess markings – permission from Angus Council was verbally given to carry on highlighting this after two complaints received that it was paramount to graffiting. Issue with Bollards at train station, Angus Council are now involved in discussions with Network Rail to look at how these can be improved for access for all. **ACTION – Councillor Wann to speak to waste department and report back at the next meeting.**
