ABSTRACT

The aim of this paper is to update the IJB Audit Committee regarding the evaluation of Microsoft Team (MST) Channel which has been established to share external, often national, reports that are of interest to the IJB Audit Committee.

1 RECOMMENDATIONS

It is recommended that the Integration Joint Board Audit Committee:-

- (i) Note the results of the evaluation of the IJB External Report MST Channel and support the recommendation to move to this format for sharing reports going forward, and
- (ii) Support the expansion of the membership of the External Reports MST Channel to include all IJB members

2 BACKGROUND

2.1 On a regular basis reports are published by external bodies that are relevant and useful to Angus IJB. Previously Audit Scotland recommended that Angus IJB consider the relevant Audit Scotland reports on a regular basis. The principle associated with Audit Scotland reports is also extended to other relevant reports. This report to the IJB Audit Committee highlights reports of relevance, but also notes specific issues or potential actions that could emanate from those reports.

Since August 2020 there has been a Microsoft Teams (MST) channel where a number of relevant external reports have been added. This gives members of the MST channel sight of these reports promptly and a chance to comment on them. Some of these reports are reflected in the reports in the list below for completeness. An evaluation of the scope to move this function (of sharing reports) away from an IJB Audit Committee report into a supported MST channel has been undertaken. The feedback is attached at appendix 1.

- 2.2 While this feedback is limited it does indicate a sense that this new way of sharing reports (via the MST channel) has potential benefits going forward as follows:
 - a) It allows reports to be shared more promptly noting the IJB Audit Committee only meets 4 times per annum.
 - b) It allows the spread of participants in the MST channel to be readily expanded to include all IJB Board members.
 - c) It allows an opportunity for members to feed back comments on reports.

- 2.3 To ensure this works smoothly and most productively the following will be required:-
 - a) The IJB's Improvement and Development team to oversee the maintenance of this MST channel.
 - b) For the IJB's Executive Management Team and others to be actively and regularly made aware of the opportunity to share reports with IJB members through this route and to be encouraged to provide brief commentary on posted reports.
 - c) For IJB members, to ensure they manage their "notifications" for this new MST channel effectively.

On that basis it is now recommended that the IJB adopts use of MST Channels to share External reports with all IJB members as described above.

It is further recommended that an annual summary of External Reports made available through this mechanism is documented at the IJB's Audit Committee at the end of every calendar year (e.g. December meeting of the IJB Audit Committee). This will provide ongoing continuity and potentially a point of further review if required.

- 2.4 This report would routinely list reports of interest in the recent months. Partly due to the time of year and potentially recent elections, there have been limited national reports issued since the last update to the IJB Audit Committee.
- 2.5 Appendix 2 gives some examples of reports previously listed on the MST channel. This could be seen to be indicative of future content.

3 CONCLUSION

- 3.1 The IJB Audit Committee is required to:
 - Note the results of the evaluation of the IJB External Report MST Channel and support the recommendation to move to this format for sharing reports going forward, with this being taken forward as described at 2.3, and
 - 2) Support the expansion of the membership of the External Reports MST Channel to include all IJB members
