CONTRACTS FOR PROVIDERS OF ADULT AND GENERAL SERVICES 2017/2018

REPORT BY VICKY IRONS-CHIEF OFFICER ANGUS HEALTH AND SOCIAL

ABSTRACT

This report seeks approval of the proposed contracts with the voluntary sector for adult services (IJB) and general services for 2017/18 and for in future years the approval of these contracts be delegated to the Chief Officer of Angus Health and Social Care Partnership.

1 RECOMMENDATIONS

It is recommended that Policy and Resources Committee;

- approves the contracts for adult services (IJB), general services and Day Care for Older People for 2017/18 as listed in Table 1,
- II. approves that in future years that approval of these contracts be delegated to the Chief Officer of Angus Health and Social Care Partnership on the basis that uplifts are contained within the overall financial framework of Angus Health and Social Care Partnership.

2 ALIGNMENT TO NATIONAL HEALTH AND WELLBEING OUTCOMES

3 BACKGROUND

- 3.1 Under the provisions of Section 4 of the Social Work (Scotland) Act 1968 a local authority may make arrangements for assistance in the performance of the functions assigned to it by organisations or persons who are able to do so. To facilitate some of these arrangements, Angus Council enters annually into a range of contracts with a number of voluntary sector service providers many on behalf of Angus Health and Social Care Partnership
- 3.2 These contracts facilitate the provision of a number of essential services through partnership working. Working in partnership with the voluntary sector is essential to the provision of effective and efficient services and brings added benefits for the people of Angus in terms of sharing skills and experience; generating new insights and solutions; and attracting additional sources of revenue funding. In a number of instances, external funding from other agencies is obtained by the providers on the strength of the commitment shown by Angus Health and Social Care Partnership.
- 3.3 It should also be noted that the services provided under the contracts are subject to the monitoring arrangements as set out in corporate standards. In addition all contracts require regular reporting on the level and quality of services provided which is actively monitored by staff within the Angus Health and Social Care Partnership and Angus Council.

4 CURRENT POSITION

- 4.1 This report includes the contracts for general services as although many are not only for adults they are the predominant service recipients.
- 4.2 For 2017/2018 it is proposed to increase the funding provided by Angus Health and Social Care Partnership for most of these contracts by 0.5 % (allowing for rounding).
- 4.3 Funding from NHS Tayside which was previously provided under the heading of Resource Transfer has now been transferred into the Angus Health and Social Care Partnerships budget and as such is not shown separately.
- 4.4 Due to funding restrictions Angus Alcohol and Drugs Partnership (ADP) have had to reprioritise their funding of some commitments and where applicable this is reflected in revised contract values. It is planned that from 2017/18 onward that ADP funding will be consolidated into overall Angus Health and Social Care Partnership budgets.
- 4.5 The funding provided by each agency is shown separately in each contract.
- 4.6 Activity measures for contracts are shown in Appendix 1. As full reporting information for 2016/2017 is not yet available the activity measures for 2015/2016 are shown.
- 4.7 Angus Council also has contracts with a range of voluntary sector providers of daycare for older people. In 2014/15 funding arrangements for these contracts were changed from a total block funding basis to a mixture of block and spot funding. The move away from block contracts is in line with the principles of Self Directed Support (SDS) which provides supported people with greater choice and flexibility in how they have their outcomes met. The split of block and spot funding is reviewed each year according to demand.. The values of these contracts have been increased to meet the Sottish Government's Scottish Living Wage requirement that all care staff be paid a minimum of £8.45 per hour. All other salary costs have increased in line with the headline local government pay award. Other (non salary) costs have been increased by inflation. While the effects of the Scottish Living Wage and inflation are known the local government pay award for 2017/18 has not been settled and an increase of 1% has been allowed meantime. If the final agreed increase is more than 1% then the increase applied will be revised up to that figure if the final agreed headline increase is 1% or less then the increase applied will remain at 1 %. Funding for daycare providers calculated on that basis is shown in Appendix 1.
 - 4.8 It is proposed that in future years that approval of these contracts be delegated to the Chief Officer of Angus Health and Social Care Partnership on the basis that uplifts are contained within the overall financial framework of Angus Health and Social Care Partnership.
