## TAYSIDE PLAN FOR CHILDREN, YOUNG PEOPLE AND FAMILIES: ANNUAL REPORT 2020-21 AND REVISED PLAN FOR 2021/23

#### **ABSTRACT**

In 2017, Angus became partners in the Tayside Collaborative for Children, Young People and Families and agreed the <u>Tayside Plan 2017 – 2020</u>. Due to the pandemic, this plan was extended to March 2021. Each year, summary reports have highlighted progress towards the ambition of the plan. The annual report for 2020-21 on progress against actions set out in the Tayside Plan is drafted for submission to Scottish Government. This report seeks approval from Angus Children and Learning Committee to submit the 2020-21 annual report which is the fourth and final report on the plan. The revised Tayside Plan for Children, Young People and Families 2021-23 is also presented to Committee for approval.

#### 2. ALIGNMENT TO THE COMMUNITY PLAN

These reports contribute to the following local outcome contained within the Angus Community Plan 2017-2030:

- Children are given the best start in life
- Physical, mental and emotional health and wellbeing is improved
- There are more opportunities for people to achieve success

It also seeks approval for the priorities in the Tayside Plan for Children, Young People and Families 2021-23 to ensure Tayside is the best place for children and young people to grow up.

#### 3. BACKGROUND

3.1 Angus Council, as part of Angus Integrated Children's Services, continue as core partners to the Tayside Collaborative for Children, Young People and Families. Part 3 of the Children and Young People (Scotland) Act 2014 requires every local authority and its relevant health board to jointly prepare a Children's Services Plan for the area of the local authority and publish regular updates on the plan. The current plan was intended to run to March 2020 however due to the impact of the Covid-19 pandemic, Angus Children and Learning Committee approved continuation of the current plan to March 2021 (Report no 237/20).

- 3.2 This annual report (appendix 1) covers the period April 2020 to March 2021 and reports on collaborative work across the region.
- 3.3 In Tayside, there remains a strong continued commitment to work in partnership with a comprehensive and inclusive approach across a wide range of public bodies, community planning partners (including the third sector) and alongside children, young people and families. At the conclusion of the period of the first Tayside Plan, partners have evaluated the collaborative position with a unanimous outcome that there remains significant benefit in continuation of the Tayside Collaborative shared planning approach and we therefore present the second iteration of the Tayside Plan for Children, Young People and Families 2021-23.

#### 4. CURRENT POSITION

## 4.1 **Annual Report 2020-21**

The annual report 2020-21 (see appendix 1) highlights the work undertaken against the 5 strategic priorities identified in the plan and progress of each of the priority groups charged with delivering improvements in the area.

- 4.2 Priority Group 1 have concluded and reported the findings of the Tayside extension pilot of Family Nurse Partnership (extended up to age 24); leadership coaching has been widely delivered and supported our approach to 1140 hours of early learning and childcare; income maximisation support for pregnant women and families has been tested and is ready for next phase of implementation and the Solihull programme for parenting has been adapted (virtual) and delivered across the region.
- 4.3 Work through Priority Group 2, Learning and Attainment was adapted significantly during 2020-21 as the focus was on delivering learning virtually and ensuring hubs were established and providing accessible and safe care for children and young people. Colleagues from across the region drew on the existing collaborative arrangements to share, adapt and deliver services during the pandemic.
- 4.4 Priority Group 3 have brought two important strategies to conclusion; Child Healthy Weight and Connected Tayside: An Emotional Health and Wellbeing Strategy for Children and Young People. The group have also supported regional approaches to the Mental Health and Wellbeing Programme and School Counselling.
- 4.5 Priority Group 4 have continued the focus on young people experiencing inequality with the conclusion of a regional review of respite and work on Secure Care Standards. As with Priority Group 2, planned work has not progressed at the intended pace as services were refocused on delivering core services to looked after and care experienced children and young people.
- 4.6 Priority Group 5 have concluded an independent review into initial and significant care reviews in Tayside. This will underpin the shared leadership and vision for protecting children over the next 3 years. There has been wide dissemination of research findings through learning materials. The key themes identified from this work has led to the development of 2 main areas of improvement: working together and relationships with children and families, as well as a series of priorities for practitioner training and workforce development.

#### 4.7 Tayside Plan for Children Young People and Families 2021-2023

In 2017 we published our first Children's Services Plan for children, young people and families in Tayside, working to our vision that Tayside will be the best place to grow up. We extended this plan to March 2021 as we worked through the Covid-19 pandemic. We have reviewed and evaluated progress on this plan, on the strengths and benefits gained through collaboration across our region and hearing from children and families about what difference our work makes and what more we need to do. This new plan for two years 2021/23 bring us into line with statutory reporting timescales for integrated children's services plans.

- 4.8 The new Tayside Plan for Children, Young People and Families 2021-2023 (see appendix 2) has been developed concentrating on fewer priorities to ensure focused collaborative work. The five key areas in the Plan remain the same. These are;
  - 1. Our children having the best start in life in a nurturing environment.
  - 2. Our children and young people being meaningfully engaged with high quality learning experiences to extend their potential.

- 3. Our children growing up healthy, confident and resilient with improving physical and mental health and strengthened emotional wellbeing.
- 4. Our children, young people and families at risk, who face significant inequalities and disadvantage, having improved life chances.
- 5. Our children and young people being safe from harm
- 4.9 We have refined the actions to support this work to ensure that they are aligned to the collaborative approach agreed and these are being taken forward by the Priority Groups already established. The overview of the action plans for each group are attached as appendices to the new plan.

The Tayside Plan for Children, Young People and Families 2021-2023:

- Reviews our collective vision and values as a collaborative, on which our actions are based.
- Identifies the longer-term priorities for improvement, which we have identified as a
  collaborative. These remain the key shared issues that we need to address to build
  on current successes and to tackle the emerging challenges presented by the Covid19 pandemic.
- Outlines how these actions will be implemented. This Plan may be updated during the course of the year, as and when needed, to reflect the impact of Tayside's recovery from Covid-19 and the further development of our Collaborative actions.
- Provides the context for our agile planning approach, through our data subgroup, Priority Groups and leadership and governance process.

#### 5. PROPOSALS

Angus Council as core partners to the Tayside Collaborative for Children, Young People and Families, will continue this commitment through delivery of the proposed plan covering the period 2021–2023 with annual reports providing opportunity for scrutiny and oversight. This report and Plan will be laid before a relevant committee/board of each of the statutory partners', by their local officers, for approval. It is therefore proposed that Committee:

- (i) Approve the annual report on Tayside Plan for Children, Young People and Families 2020-21.
- (ii) Approve the revised Tayside Plan for Children, Young People and Families 2021-23.
- (iii) Direct the Depute Chief Executive to bring an annual report to committee following the end of reporting period to March 2022.
- (iv) Note the intention to publish both documents on the Tayside Regional Collaborative Website after 7 September 2021 to enable all relevant Tayside authorities to consider and approve.
