Chairman's Report 2020/21

The spread of Covid 19 and the subsequent national lockdowns and restrictions have resulted in there being no Community Council meetings since February 2020. It was decided not to attempt online meetings because of the likelihood of connection problems in such a rural area. Email communications have however continued throughout this period.

Issues which have been dealt with by community councillors throughout the pandemic have included:

involvement with the planning application for a caravan park at Ruthven;

attendance at meetings hosted by Scottish Water regarding problems with camping, litter and some abusive behaviour at Lintrathen Reservoir;

agreement to support extra-curricular music at Isla Primary school;

flytipping and road related issues in Westmuir;

attendance at appropriate community meetings held by Angus Council;

communicating with Angus Council and Scottish Water about road access problems in and around Kilry during the work to install a much needed new water main and similarly liaising with Scottish Water and contractors during the replacement water main works for Westmuir from July 2020 - April 2021.

This list is not exhaustive but does illustrate that the work of the Community representatives has continued in spite of the restrictions.

The continued engagement of the Police with the rural community through the monthly bulletin has been appreciated especially in the absence of the usual meetings.

I am grateful to all the community councillors for their contributions not least Sue Smith for her work as Treasurer and Geoff Hobson for his IT and planning officer work and for filling the role of vice chairman.

Finally thanks to our Angus Councillors for their support over this difficult pandemic period not least with the various newsletters and updates.
