COVID RECOVERY – A CONSULTATION ON PUBLIC SERVICES, JUSTICE SYSTEM AND OTHER REFORMS

REPORT BY THE DIRECTOR OF LEGAL AND DEMOCRATIC SERVICES

ABSTRACT

This report advises the Committee of the Scottish Government Consultation on "Covid Recovery – A Consultation on Public Services, Justice System and Other Reforms". The deadline for responses is 9 November 2021. A proposed response on behalf of Angus Council is attached at Appendix 1 and Members are asked to consider this draft response and to provide any further comments prior to approving a final response for submission.

1. RECOMMENDATIONS

- 1.1 It is recommended that the Committee: -
 - (i) Notes the Scottish Government Consultation on "Covid Recovery A Consultation on Public Services, Justice System and Other Reforms" as detailed in this report;
 - (ii) Considers the Council's draft response to the consultation attached at Appendix 1, provides any further comments for inclusion in the final response and agrees a final response; and
 - (iii) Approves the Director of Legal and Democratic Services' submission of the Council's final response to the Scottish Government.

2. ALIGNMENT TO THE COUNCIL PLAN

Given the wide-ranging topics in the consultation, the report is relevant to all aspects of the Council Plan 2021-24 priorities.

3. BACKGROUND

- 3.1 On 17 August 2021, the Scottish Government published a Consultation on "Covid recovery: public health, services and justice system reforms". Further detail can be found here:

- 3.2 It is the intention of the Scottish Government to remove measures no longer needed in order to respond to the pandemic whilst keeping those where there is demonstrable benefit to the people of Scotland. The Consultation paper focuses on reviewing the legislative powers that have supported the Government's response to Covid and invites comments on the action that respondents think is required to support a fair, safe and secure recovery.
- 3.3 The Consultation invites views on specific legislative proposals that have the potential to support Covid recovery, including: -
 - Proposals for greater public health resilience, to protect Scotland against future public health threats:
 - Proposals for public services and justice system reform, to ensure that the benefits of practical modernisations put in place during the pandemic are maintained; and

 Proposals to respond to the impact of Covid in the justice system specifically, where backlogs have unavoidably built up.

The table below outlines each area of proposed change. These are primarily operational in nature.
