# THE ANGUS COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING) (ON-STREET PARKING) (DECRIMINALISED ENFORCEMENT) (VARIATION) ORDER 2021

Angus Council, in exercise of the powers conferred on them by Sections 32, 35, 35A and 124 of the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the Act"), the Road Traffic Act 1991, the Road Traffic (Permitted Parking Area and Special Parking Area) (Angus Council) Designation Order 2017 and of all other powers enabling them in that behalf and after consultation with the Chief Constable of the Police Service of Scotland in accordance with Paragraph 20 of Schedule 9 to the Act hereby make the following Order:-

- 1. This Order may be cited as the Angus Council (Prohibition and Restriction of Waiting and Loading) (On-Street Parking) (Decriminalised Enforcement) (Variation) Order 2021 and shall come into operation on 8<sup>th</sup> November 2021.
- 2. The Orders specified in Schedule 1 to this Order are hereby varied and shall henceforth have effect subject to the amendments thereto specified and described in the said Schedule.
