# Legal Duty of the Council

- **1985 Transport Act** – is the basis for local authorities to support the public transport network
- Section 63 – places duty on Councils to prepare general public transport policies
- Section 64 – there should be consultation on any policies with the public and neighbouring authorities
- **2005 Transport Act** – created Regional Transport Partnerships (Tactran). Local authorities must pay attention to public transport aims and objectives outlined within the Regional Transport Strategy

# Public Transport Policy


- The main aim of the council is to –  
“Provide public passenger transport services to meet the needs of local residents and visitors to the area, providing access to those without a car and an attractive and sustainable alternative for those with access to a car.”

# Public transport services - Budget & Delivery

- The public transport services budget for 2021/22 is **£1.9million**.
- This amount is provided to the local bus operators that deliver all of our public transport services.
- We also pay one taxi firm for a small DRT (demand responsive transport) service.

# Public transport services - Budget & Delivery

The public transport revenue budget allocation for 20/21 was £1,919,000:



- 99.8% of the money spent from the transport revenue budget in 20/21 was for local bus services


# Emerging Key Issues

# Sustainable Travel Hierarchy


- Priority for pedestrians

- Priority for private cars
