Helen Smith welcomed everyone to the meeting.

Matters arising

Caravans, Kinnaber Road, Hillside

No change in situation.

Flooding on Main Road, Hillside

Tony said that there were men with cameras down the drains last week, so work is ongoing. There have been no recent issues with flooding.

A937 Craigo Road (speeding)

An email dated 19 October 2021 from Cllr Duff stated that a speed survey carried out on the A937 at North Craigo between 18 Aug 2021 and 25 Aug 2021 recorded an average speed of 38 mph and an 85th percentile speed (the speed at or below which 85% of vehicles were travelling) of 44 mph. A search of our road traffic accident database confirmed that there have been no recorded injury accidents on the A937 in the vicinity of North Craigo during the most recent 3-year recording period from 30 May 2018 – 29 May 2021. A site visit carried out on the 24 June 2021 observed that the junction markings were in reasonable condition and did not require to be refreshed. Other warning signs and markings were also observed in advance of the junction in both directions on the A937 and were clearly visible to oncoming traffic.

Therefore taking all of this into consideration the Group (Angus Area Traffic Co-ordination Group – which includes Angus Council and Police Scotland) agreed that there was not a significant speeding issue on the A937 at North Craigo and that no action was required by the Group regarding the signs and road markings. This item will be removed from the agenda.
