1. Welcome and Apologies

2. Minutes of Meeting on 26th August 2021. Approved**3. Matters arising from previous meeting**

The Kilry Hill verge issue was passed onto Roads Department and it has been resolved but there is a residual issue of water on the road.

HH reported back from the Biannual CC meeting on Admin support for CC's but that issue for KLWCC has now been resolved with the appointment of Secretary and Treasurer.

Road speeding issues still considered to be a problem in the 20mph zone in Westmuir, but the 18 month review period is still in place until late Autumn 2022 so is still being monitored.

Sat Nav issue – HH to see if people are still having problems and the suggestion received was to contact the company who prepared the postcode boundaries for DD8 5NA.

Abandoned Cars – there has been a big improvement and the situation is being closely reviewed.

The Westmuir unadopted road issue will be carried forward to the next meeting.

SS thanks the Council for their help over events at Balintore Castle which had improved

4. Appointment of Secretary and Treasurer

Meg Mearns had agreed to take on the role of Secretary and Sally Colville had agreed to take on the role of Treasurer. These appointments were agreed by the members.

5. Co-opting new member for Ruthven

6. Financial Position

The mandate for the signatories to be changed to SS and SC is underway. The £400 Annual allowance from the Council is there to be utilised, such as for paper, inks, Zoom licence (if required).
