COVID-19 FUNDING - DISCRETIONARY FUNDING PROJECT APPROVALS

REPORT BY IAN LORIMER, DIRECTOR OF FINANCE

ABSTRACT

This report seeks member agreement to use Scottish Government COVID-19 funding provided to the Council to help support local people and communities where the Council has a degree of discretion over the use of the funding.

1. **RECOMMENDATIONS**

It is recommended that the Council:

- (i) Approve the proposed use of COVID-19 funding as set out in this report and Appendix 1;
- (ii) Note return of previously approved COVID-19 funding set out in this report; and
- (iii) Note the decisions made under delegated authority for use of 2021 Winter Flexible Fund as set out in this report and Appendix 2.

2. ALIGNMENT TO THE COUNCIL PLAN

- 2.1 This report contributes to the following strategic priorities in the Angus Council Plan: We want:
 - To maximize inclusion and reduce inequalities
 - Our communities to be strong, resilient and led by citizens
- 2.2 In light of the COVID-19 pandemic we have looked again at our priorities to best support our people and our businesses in Angus to recover and renew over the short, medium and longer term. We have looked at our response to COVID-19, the strong partnerships developed, the pace at which we responded and how we adapted our ways of working to support our citizens.
- 2.3 As will be evident from the report contents, the Council and Third Sector partners continue to be on the front line in providing support to people in response to, and recovery from, the pandemic and these support actions contribute to many of the priorities and ambitions in the Council Plan.

3. BACKGROUND

- 3.1 Reference is made to Report 216/21 considered by the Council at its meeting of 24 June 2021, which gave background on the range of grants being provided and how these would be managed through a mixture of delegated authority and seeking prior member approval. This report covers the use of funding which, although intended by the Scottish Government to help Councils provide support to local communities, involves discretion and choice on how the Council does that.
- 3.2 Additionally, reference is made to Report 392/21 considered by the Council at its meeting of 16 December 2021, which noted the urgency regarding use of funding provided by the Scottish Government to prevent and respond to financial insecurity this winter. Approval was made by members to delegate authority to the Director of Finance to approve project proposals for the use of this funding on the basis that a report informing elected members of those delegated decisions will be provided in the February cycle of meetings.
- 3.3 Responding to the pandemic continues to be a huge challenge and this report therefore seeks member agreement to use some of the Government COVID-19 funding provided to the Council where the Council is able to use the funding on a discretionary basis.

4. CURRENT POSITION

- 4.1 Level 4 Flexible Fund, Angus Council Allocation £653,000
- 4.2 Angus has received a Flexible Fund allocation of £653,000, of which £591,933 has been spent to date, and £61,067 remains to be spent.
- 4.3 Local Authority Top Up Administration Grant Tranche 1, Angus Allocation £256,000
- 4.4 Angus has received COVID-19 Administration Grant Funding of £256,000, of which £243,863 has been spent to date, and £12,137 has been committed but remains to be spent.
- 4.5 Reference is made to Report 216/21 considered by the Council at its meeting of 24 June 2021, which recommended that the Council approve the proposed use of COVID-19 funding of £3,000 for associated costs of distributing Schools Direct Payments and School Grant Allocations to families.
- 4.6 Following Council approval, the applicant withdrew the request. The amount of £3,000 has been added back to the remaining balance of this fund.
- 4.7 Scottish Government 2021/22 Winter Flexible Fund, Angus Allocation £485,000
- 4.8 On 29 November 2021, Scottish Government wrote to Local Authorities confirming £25 million of flexible funding as part of the Winter Support Fund. The purpose of the flexible funding is to enable local authorities to support wellbeing by preventing and responding to financial insecurity. Activity must take place by end March 2022 in order to report to Scottish Government in April 2022.
- 4.9 Guidance was published on 11 November which provides a strong steer in favour of cash-first responses, and the integration of money advice and holistic support services to prevent future hardship. Local authorities have the flexibility to adapt interventions to meet emerging needs, action may include:
 - Emergency financial assistance
 - Direct assistance to access food, fuel and other essentials
 - Other activities and services, as necessary, to support individuals to overcome financial crisis
 and support wellbeing, including targeted activity to support marginalised groups, activity to
 prevent and address homelessness, and funding to community and third sector organisations
- 4.10 Angus has received Scottish Government 2021/22 Winter Flexible Fund of £485,000, of which £340,334 has been committed to date as set out in this report and Appendix 2, and £144,666 remains to be spent. Work is ongoing to ensure these remaining funds can be spent to support people in need across Angus with tackling food and fuel poverty being a specific focus. Allocation of the remaining funds will be reported to members in a future update report.

5. PROPOSALS

5.1 Details of the individual projects for which formal approval is sought are contained in Appendix 1 in this report. The Grants Assessment Panel and Grants Sub-Group of officers' views were sought regarding the proposed projects and the recommendations are noted in Appendix 1.

6. FINANCIAL IMPLICATIONS

6.1 The financial impact is covered by additional government funding provided to the Council as COVID-19 funding for specific schemes the Government has asked Councils to administer on their behalf.

6.2 A summary of the financial implications are outlined below if the Council are minded to agree all the proposed projects in Appendix 2.
