BALNUITH – Planning Enf Case 18/00016/UNWRKS: email response received from Angus Council. AC are “aware of further developments at this site and will be undertaking a joint officer visit in the very near future.” “...are now considering formal action as informal means have not resulted in the result we would like to see.” “...also considering Scottish Government guidance which remains in force which reads at this time: *Local Authorities should only consider eviction or dispersing a camp where the location of an encampment is unsuitable for health or safety reasons or if there is another good reason, for example antisocial behaviour or persistent breach of Covid 19 travel advice. In this case, an alternative, suitable location should be identified where possible. We have to balance any action against this and make sure it is a proportionate response.*”
