## "External" Posts Where Additional Remuneration Can Apply

Tayside Joint Valuation Board - the Board needs to decide on its Remuneration arrangements but based on custom and practice Angus Council has the Spokesperson position for the next 5 years (a non-remunerated post) because the Angus rep was the Convener for the last 5 years

The Cairngorms National Park Authority Board - The Angus Council representative gets a fee of £8,163 which is paid directly by the Park Authority plus expenses. Fee levels are set by the Park Authority based on a framework and guidance from Scottish Ministers on the basis of an assumed time commitment of 30 days p.a. Payment of this fee sits entirely out with the main remuneration arrangements for Councillors so has no bearing on the number of senior councillors, etc.

Tayside NHS Board - The Angus Council representative gets a fee of £8,930 which is paid directly by the NHS Tayside plus expenses. Remuneration levels are set by the within a framework and guidance from Scottish Ministers. Payment of this fee sits entirely out with the main remuneration arrangements for Councillors so has no bearing on the number of senior councillors, etc.

## **Financial Implications**

The proposed structure and the costs arising are in compliance with the Remuneration Regulations.

Employers costs for national insurance and pension contributions will be payable in addition to the total cost shown of £636,273. Actual pension costs will however depend on how many elected members choose to be members of the pension scheme (all elected members under 75 are autoenrolled in the scheme but can opt out). Assuming past trends on pension scheme membership continue the budget provision of £777,000 will be sufficient to meet all costs including employers costs. In the event that all elected members choose to be in the pension scheme it will be necessary to adjust the budget accordingly through budget virements which will be reported to the Policy & Resources Committee for approval.

- (v) agrees to delegate authority to the Director of Finance to apply any non-material changes to the remuneration structure following consultation with both the Leader of the Council and the Leader of / Spokesperson for the Non-Administration / Opposition;
- (vi) notes that opportunities for further reform of Committee and remuneration arrangements could be considered in due course if required.

The Council agreed to have a 10 minute adjournment to allow members the opportunity to consider the terms of the motion.

The meeting re-convened at 3.50pm

\*At this stage in the meeting, the Manager Democratic and Members Services indicated that in relation to the votes for appointment to CGLMC (item 9 above), Councillor Cheape had received 16 votes, Councillor Braes had received 16 votes and Councillor Nicol had received 10 votes. He had erroneously indicated at the time of the vote that Councillor Cheape had received 15 votes. This had not affected the outcome of the vote.

The Council thereafter agreed to approve the proposals as detailed in (i) - (vi) above.

# 11. THE ETHICAL STANDARDS IN PUBLIC LIFE ETC (SCOTLAND) ACT 2000 THE COUNCILLOR'S CODE OF CONDUCT

There was submitted Report No 129/22 by the Director of Legal and Democratic Services advises Council members of their responsibilities as Councillors under the Councillors' Code of Conduct, (the Code).

The Report indicated that The Ethical Standards in Public Life etc (Scotland) Act 2000 introduced a new code of conduct for local authority councillors and members of relevant public bodies and established a Standards Commission for Scotland to oversee the new framework. The Standards Commission is the regulatory body responsible for the Code. They raised awareness and understanding of the Code by issuing Guidance, Advice Notes &

Standards Updates, through training events, and by answering queries and providing advice to councillors, council employees and members of the public.

Their overall aim was to prevent breaches of the Code from occurring. The Standards Commission also has an enforcement role through its work on adjudicating on complaints and in imposing sanctions when a breach is found. Any allegations of a breach of the Code of Conduct are investigated in the first instance by the Commissioner for Ethical Standards. A revised Councillor's Code of Conduct had come into effect in December 2021 with Guidance on how to interpret the provisions within the Code. The Code was directed to Councils and Councillors, but it was also directed to co-opted members of committees and sub- committees who were not elected members.

The Council agreed:-

- (i) to note the legislative framework on the behaviour and conduct required of Councillors which is aimed at promoting the highest standards in public life; and
- (ii) to note the specific requirements in relation to registration and declaration of interests.

## 12. TIMETABLE OF COUNCIL MEETINGS

There was submitted Report No 132/22 by the Director of Legal and Democratic Services setting out a Timetable of Meetings for the period August 2022 – June 2023.

In addition to the meetings shown in Appendix 1 to the Report it would be necessary to arrange a Special Meeting of the Council to set the 2023/24 General Fund Revenue and Capital Budgets and Council Tax and a Special Meeting of the Communities Committee to set the 2023/24 Housing Revenue and Capital Budgets and Council Rents. The timing of these meetings could not be confirmed at the moment because they relied on publication of information by Scottish Government, the timing of which was uncertain.

The Council agreed to approve the Timetable of Meetings covering the period August 2022 - June 2023, attached as Appendix 1 to the Report.
