# ANGUS COUNCIL (WEIGHT LIMITS ON ROADS)(HAYSHEAD ROAD, ARBROATH)(VARIATION) ORDER 2022

Angus Council in exercise of the powers conferred on them by Sections 1(1), 2, 3(2), 4(1), and 124(1) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended (which Act of 1984 is hereinafter referred to as "the Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Paragraph 20(1) of Schedule 9 to the Act hereby make the following Order:-

- 1. This Order may be cited as the "Angus Council (Weight Limits on Roads)(Hayshead Road, Arbroath)(Variation) Order 2022" and shall come into operation on the 13<sup>th</sup> June 2022.
- 2. The Order specified in the Schedule to this Order is hereby varied and shall henceforth have effect subject to the amendments thereto specified and described in the said Schedule.
- 3. The road affected by the amendments to the Order, as specified in the said Schedule to this Order, is shown hatched in black on the plan annexed hereto.
