#### **Director of Finance Commentary**

The Motion would represent a significant policy commitment for the Council which, given the enormity of the financial challenges facing the Council in the short and medium term, it may be difficult to sustain or could mean other less palatable budget choices having to be made at some point in the future. If the Council is minded to support this motion then given the significance of the policy commitment proposed it should, in accordance with the Council's Options Appraisal Guidance (Report 338/21 to Angus Council on 4 November 2021 refers), be subject to an options appraisal prior to being adopted as Council policy.
