Material changes -


- 1. Portal has not opened for applications providing more time to analyse the Bid

Derek,

Please find below a summary of a proposed reduced project scope as discussed between Jill and yourself.

- 1. Coach & EV Facilities
- 2. Bog Road Bridge Replacement and Station Access Improvements
- 3. Active Travel Route Brechin Station to Nature Trail via Andover School (including Loading Dock access improvements)
- 4. Brechin Steam Shed event space
- 5. Maintenance, Training and R&D Facilities
- 6. Heritage railway turntable

The total project costs for the above elements is approx. £9.648million.

While this would not be our preferred option, it does offer some flexibility to the council and is much more aligned with regards to costs of the previously supported proposal for the Showcase the Street project submitted in round 1 approximately 12 months ago. It also still offers good value for money and the potential to apply for further project elements in a round 3 application if there ever is a round 3.
