THE ANGUS COUNCIL (FORMER A92 ARBROATH - MONTROSE ROAD AND ARBIKIE ROAD, INVERKEILOR) (STOPPING UP) ORDER 2015

Angus Council, in exercise of the powers conferred on them by Section 68(1)(b) of the Roads (Scotland) Act 1984 and all other powers enabling them in that behalf, having considered that those former sections of the A92 Arbroath - Montrose Road and Arbikie Road (Branch), Inverkeilor specified in the Schedule to this Order are unnecessary, and being satisfied that suitable alternative roads exist, hereby make and confirm the following Order:-

1. This Order may be cited as "The Angus Council (Former A92 Arbroath - Montrose Road and Arbikie Road, Inverkeilor) (Stopping Up) Order 2015 and shall come into operation on Twenty seventh April Two thousand and fifteen.
2. The stopping up of the sections of former roads specified in the Schedule to this Order is hereby ordered.
3. Where there is, immediately before the date on which the said length of road is stopped up under the Order, any apparatus belonging to any statutory undertakers under, in, on, over, along or across that length of road for the purpose of carrying on their undertaking the said statutory undertakers shall after commencement of this Order continue to have all rights in respect of the said apparatus as they had immediately before that date.

SECTIONS OF PUBLIC ROAD TO BE STOPPED UP

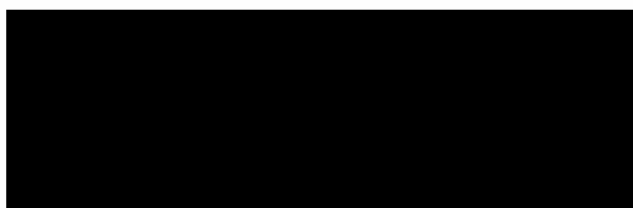
- That section of the former A92 Arbroath - Montrose Road from a point 490 metres or thereby southwestwards from the junction of Courthill Road (formerly A92 Arbroath - Montrose Road) with Hawkhill Road (formerly Arbikie Road (branch)) southwestwards for a distance of 630 metres or thereby (marked A - B).
- That section of the former A92 Arbroath - Montrose Road from a point 110 metres or thereby northeastwards from the junction of Courthill Road (formerly A92 Arbroath - Montrose Road) with Hawkhill Road (formerly Arbikie Road (branch)) generally northeastwards and northwards for a distance of 835 metres or thereby (Marked C - D).
- That section of Arbikie Road (branch) for a distance of 675 metres or thereby southeastwards from its junction with Arbikie Road (Marked E - F).

all as shown zebra hatched on the plan annexed and signed as relative hereto.

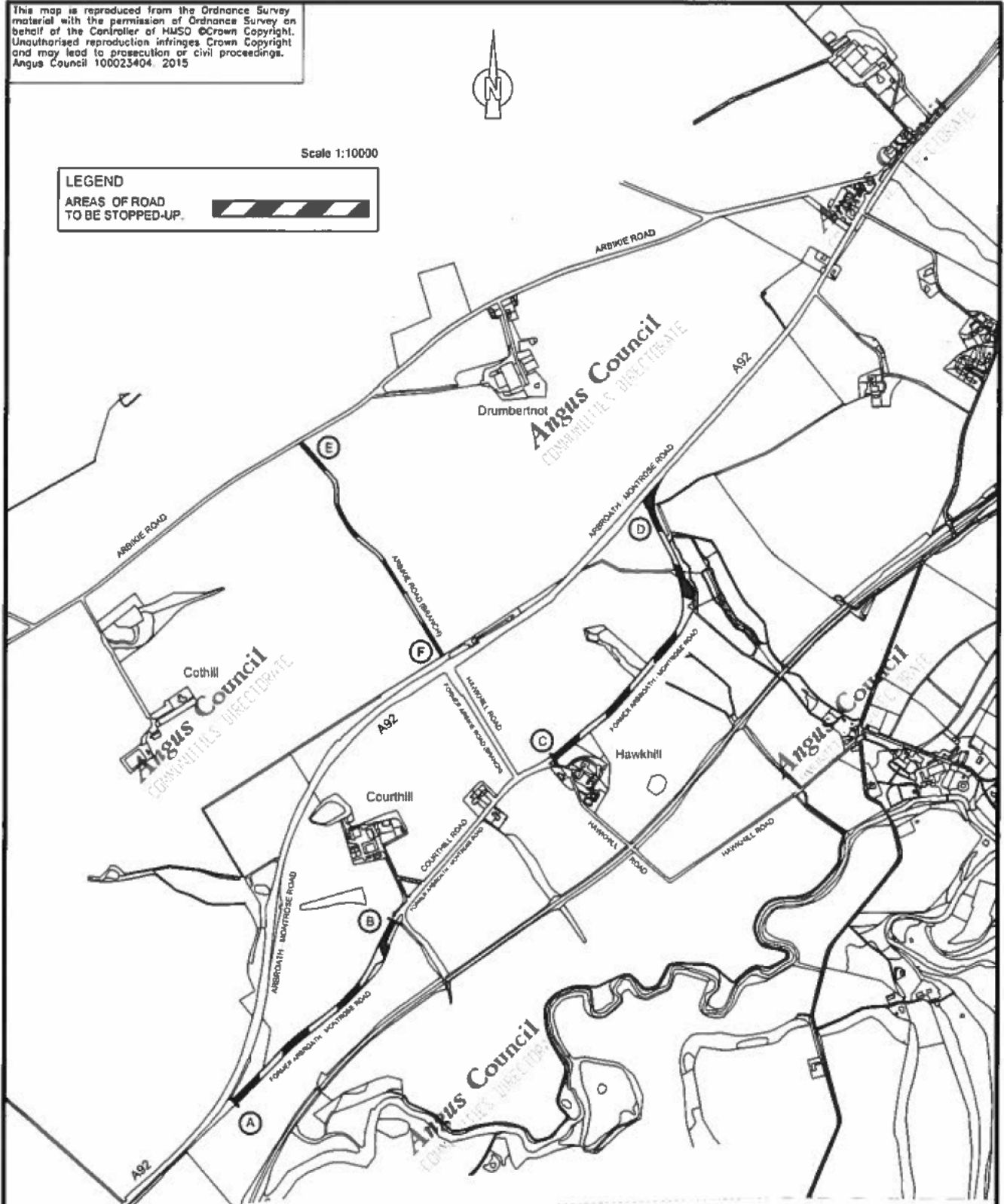
