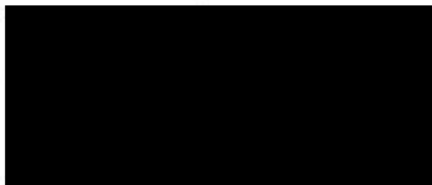

The impact of such a turbine is far greater than the 20 metre limit suggests in this instance. Within 2000 meters there are no fewer than 9 other residences overlooking the site which is in a tranquil valley in an area frequented by walkers, cyclists, multiplied since C-19, and horse riders (there are three equestrian centres locally) and overlooked by Ford House, Rossie School's accommodation for rehabilitating residents.

A far better site for the turbine would be NNE of Drumbertnot towards the industrial complexes of Gorilla Corrosion Works, the distillery itself and Stir Fresh at Upper Dysart rather than on a country track near Gightyburn water course.

Comment: I am writing to object to the planning application for a wind turbine at Arbikie.

Planners face striking the balance between competing interests.

In this case, it is between retaining the exceptional landscape quality of the greater Lunan area and needs of one small industrial enterprise who seek to claim certain sustainability.

The opening paragraph of the Visit Angus site states: "Angus has it all, from the breathtaking scenery of the rolling hills and glens, to the sandy white beaches along the stunning coastline."

The site lists Red Castle, Lunan beach and Elephant Rock as attractions of importance.

Lunan Bay now has a successful hotel, bunkhouse and café which is attracting new visitors to the area. This offers a sustainable contribution to employment and to the economic well being of the locality and may be imperilled by a turbine in this location.

The 4 ZTV maps show the very broad extent of the visibility of this turbine. It looks to me that it will be visible from over 50% of the 5km local area. It will be visible from the north, south, east and west. It will be visible from the beach. The maps do show the full extent of the visibility but it will not be seen from Aberdeenshire. The map shows the core paths in the area that will be impacted. Currently as you walk from Auchmithie to Lunan bay and look inland there is a classic Angus coastal skyline.

As you play and swim on the beach, you look up to an unobstructed skyline.

And views along the sky line as you travel from Arbroath to Montrose will be damaged.

This turbine development goes against a broad public good, namely saving the iconic views that were portrayed in the work of the artist James Morrison. He opposed a number of such proposed constructions in the immediate vicinity for this reason.

It will cause an adverse impact on the development of tourism along Angus's coastline.

I urge the Council to reject this application. The visual intrusion is far too great.

1. We have not been notified, yet our home and the six other Mountboy residences are only 1000 metres from the proposed site, whereas the occupants of the Drumbertnot Cottages, who have been notified, are 1,800, meters from the site: almost twice the distance.
2. Within that 1,800-meter circle are the (privately owned) Arbikie Cottages, Ingersol Cottage, Cothill, Knappie Roondie (North Mains of Hilton), Hilton Farmhouse, Renmuir, Pamfrey, Gighty Burn Cottage and Ford House, Rossie School.
3. Why were not these establishments/residences advised?

We note this application is not of an industrial scale, such as the last project proposed on Mountboy land, and that it is designed for the dedicated powering of the distillery at Drumbertnot. That distillery already impacts on the residences here at Mountboy due to the smell from the daily dumping of waste water on Rossie/Mountboy farmland.

We set out our fundamental objections to the application below:

1. The proposed site is in the very centre of a tranquil valley enjoyed by local residents, walkers and cyclists, (who have multiplied since C-19), and horse riders. There are no fewer than three equestrian centres locally.
2. The proposed site is on a country lane and close to Gighty Burn, an important water course.
3. A much better site for this turbine would be to the East North East, i.e. the other side of Drumbertnot where there are industrial complexes already, viz the distillery itself, Gorilla Corrosion Works, and Stir Fresh, located at Upper Dysart, and linked to the
4. same owners. It would seem the only residents there who might be impacted would be those in a singular Upper Dysart cottage.
