### **Alison Smith, Vibrant Communities Team**

2 main messages – encourage groups to take ownership, different ways of funding

Concerns -

- Fairy Steps – *due to ongoing costs, agreement, works and maintenance – Countryside Scotland Act 1967 – public right of way (6 years left)- public liability*
- Pentanque pitch – *Maule Street, Millennium fund – National venue needed bringing tourists to area 4 nations tournament – over 1,000 west Lothian – need safe access to public parks – 12 members over 80 ( and two over 90) - membership increased to 25%. Raised money for piste, reinstate parks – open at all times. Equalities issues -*
- Recycling centre – *waste management, general waste -*
- Christmas lights – *Walter Scott & Lisa Childs - infrastructure –command light box – suggestions – despite it being work of Angus Council*

Place Based investment Fund – 5 year fund = expressions of interest £624,000
