ABSTRACT

This report presents the Scrutiny and Audit committee 2021/22 annual report for comment and approval.

1. RECOMMENDATIONS

2. ALIGNMENT TO THE COMMUNITY PLAN/COUNCIL PLAN

The work of the Scrutiny and Audit Committee, summarised in the annual report, contributes to the achievement of the corporate priorities set out in the Community Plan and the Council Plan.

3. BACKGROUND

Guidance published by CIPFA in 2018 is accepted as best practice for local authority audit committees. CIPFA guidance recommends that all audit committees should "report regularly on their work, and at least annually report an assessment of their performance". (Audit Committees Practical Guidance for Local Authorities and Police).

The first annual report from the Scrutiny and Audit Committee was submitted to Council in September 2018.

4. CURRENT POSITION

The annual report at Appendix 1 has been prepared to inform Angus Council of the work undertaken by the Scrutiny and Audit Committee during 2021/22. It includes an action plan for 2022/23 and an update on the actions identified in last year's annual report. The report concludes:
