Mental Health and Wellbeing Strategy now being operationalised. However, full financial framework still requires significant development. This requires input from NHS Tayside, as holders of operational responsibilities, and IJBs, as holders of strategic responsibilities. It is anticipated that collaborative work, linking in with Mental Health Leadership Team will progress prior to December 2022. Limited progress with overall financial planning but a workplan with lead responsibilities has been developed and is being progressed.
