Delivery of specialist service providing assessment and programme intervention for those convicted of sexual offences by Tay Project, as a requirement of the Court as part of services required under section 27 of the Social Work (Scotland Act) 1968 (as amended).

The proposal is seeking approval for payments to Dundee City Council to continue the partnership approaches with Dundee City and Perth and Kinross Councils to deliver key justice social work services, with note to the partnership arrangement in place for the delivery of a Custody Assessment and Referral Service pilot project.

Dundee City Council host the Tay Project, a specialist service providing assessment and programme intervention for those convicted of sexual offences, as a requirement of the Court. This is delivered on a pan-Tayside basis, with grant contributions from Perth and Kinross and Angus Councils. The purpose of this report is to provide and update and seek approval to continue funding this service.

#### Age Impact - Neutral

The proposals (Tay Project/ Custody Assessment and Referral Service Pilot/ The Caledonian System) do not discriminate on age. Expected to have a positive impact across all age groups across the Angus area requiring these services.

#### Disability Impact – Neutral

The proposals/services are accessible to those with a disability.

Given Angus is a rural LA the review of public transport will potentially have a positive impact on people with a disability as it aims to make the transport system more accessible which should improve people's access to services

It is hoped the Caledonian System which takes an integrated approach to addressing domestic abuse combining a court-ordered programme for men, aimed at changing their behaviour, with support services for women and children with have a positive impact on people in all different types of partnerships.

#### Pregnancy/Maternity Impact - Neutral

Although again early support for pregnant woman experiencing domestic abuse through Caledonian System likely to have a positive outcome on women and their unborn babies

Race - (includes Gypsy Travellers) <u>Impact</u> - Neutral No restrictions to access services based on race including Gypsy Travellers.

Religion or Belief <u>Impact</u> - Neutral No restrictions to access services based on religion or beliefs of individuals

#### Sex Impact – Positive

Women are disproportionality affected by domestic abuse, service for women and their children as well working with men to change behaviours will positively impact on individual and families. The Caledonian System is supported by national funding and infrastructure and the continues partnership approach to delivery will help ensure that high quality, resilient, public protection services remain accessible in Angus.

The Tay Project, a specialist service hosted by Dundee City Council providing assessment and programme intervention for those convicted of sexual offences (as a requirement of the Court) provides a specialist service which helps to keep citizens of Angus safe and supporting positive behaviour change for those convicted of sexual offences.

Sexual orientation <u>Impact</u> – Neutral No restrictions to access services based on sexual orientation.

The Justice service works in a trauma informed way, taking a relationship-based approach which enables all individuals who access services to be supported many of whom have experience exclusion from the wider community. Services outlined in the proposal supports improved health and wellbeing through access to early help and support and reduces inequalities for individuals at risk of offending or returning to their community.
