Angus Council Audit of 2021/22 annual accounts

Independent auditor's report

1. Our audit work on the 2021/22 annual accounts is now substantially complete. Subject to the satisfactory conclusion of the outstanding matters referred to later in this letter and receipt of a revised set of annual accounts for final review, we anticipate being able to issue unqualified audit opinions in the independent auditor's reports on 29 November 2022. The proposed report for the council is attached at **Appendix A**; for Angus Council Charitable Trust at **Appendix B**; and for Robert & William Strang Mortification at **Appendix C**).

Annual audit report

- **2.** Under International Standards on Auditing in the UK, we report specific matters arising from the audit of the financial statements to those charged with governance of a body in sufficient time to enable appropriate action. We present for the Scrutiny and Audit Committee's consideration our draft annual report on the 2021/22 audit. The section headed "Significant findings from the audit in accordance with ISA 260" sets out the issues identified in respect of the annual accounts.
- **3.** The report also sets out conclusions from our consideration of the four audit dimensions that frame the wider scope of public audit as set out in the Code of Audit Practice.
- **4.** This report will be issued in final form after the annual accounts have been certified.

Unadjusted misstatements

- **5.** We also report to those charged with governance all unadjusted misstatements which we have identified during our audit, other than those of a trivial nature and request that these misstatements be corrected.
- **6.** We have identified no unadjusted misstatements above our reporting threshold in the council accounts.
- **7.** We have identified one unadjusted misstatement in the Robert & William Strang Mortification accounts which is above our reporting threshold for the charitable trust. This was a transaction posted twice in the ledger, which has been reversed in 2022/23. This overstates 2021/22 expenditure on charitable activities in the Statement of Financial Activities and understates the total charity funds in the Balance Sheet by £133. Management do not propose to amend the 2021/22 accounts for this as it is not a material amount.

Fraud, subsequent events and compliance with laws and regulations

8. In presenting this report to the Scrutiny and Audit Committee we seek confirmation from those charged with governance of any instances of any actual, suspected or alleged fraud; any subsequent events that have occurred since the date of the financial statements; or material non-compliance with laws and regulations affecting the entity that should be brought to our attention.

Representations from Section 95 Officer

- **9.** As part of the completion of our audit, we are seeking written representations from the Section 95 Officer on aspects of the annual accounts, including the judgements and estimates made.
- **10.** A draft letter of representation is attached at <u>Appendix D</u>. This should be signed and returned to us by the Section 95 Officer with the signed annual accounts prior to the independent auditor's report being certified.

Outstanding matter

- **11.** There is one area where we still require additional information, and this is identified below:
 - Final journals to be posted for the charitable trusts (revenue account and Loans Fund cash movements)

Opinion on financial statements

- **2.** I confirm to the best of my knowledge and belief and having made appropriate enquiries of the Chief Executive and Corporate Leadership Team, the following representations given to you in connection with your audit of Angus Council's and the charitable trusts' annual accounts for the year ended 31 March 2022.

General

- **3.** Angus Council, the charities' trustees and I have fulfilled our statutory responsibilities for the preparation of the 2021/22 annual accounts. All the accounting records, documentation and other matters which I am aware are relevant to the preparation of the annual accounts have been made available to you for the purposes of your audit. All transactions undertaken by Angus Council and its group, Angus Council Charitable Trust and Robert & William Strang Mortification have been recorded in the accounting records and are properly reflected in the financial statements.
- **4.** I confirm that the effects of uncorrected misstatements are immaterial, individually and in aggregate, to the financial statements as a whole. I am not aware of any uncorrected misstatements other than those reported by you.

Financial Reporting Framework

5. Angus Council's annual accounts have been prepared in accordance with the Code of Practice on Local Authority Accounting in the United Kingdom 2021/22 (2021/22 accounting code), and in accordance with the requirements of the Local Government (Scotland) Act 1973,

the Local Government in Scotland Act 2003 and The Local Authority Accounts (Scotland) Regulations 2014.

- **6.** The charities' annual accounts have been prepared in accordance with the Charities and Trustee Investment (Scotland) Act 2005, Charities Accounts (Scotland) Regulations 2006 (as amended) and the provisions of the charities' constitutions.
- **7.** In accordance with the 2014 regulations, I have ensured that the financial statements give a true and fair view of the financial position of Angus Council and its group, Angus Council Charitable Trust and Robert & William Strang Mortification at 31 March 2022 and the transactions for 2021/22.

Accounting Policies & Estimates

- **8.** All significant accounting policies applied are as shown in the notes to the financial statements. The accounting policies are determined by the 2021/22 accounting code where applicable. Where the code does not specifically apply I have used judgement in developing and applying an accounting policy that results in information that is relevant and reliable. All accounting policies applied are appropriate to Angus Council and its group's circumstances, or to the charities' circumstances, and have been consistently applied.
- **9.** The significant assumptions used in making accounting estimates are reasonable and properly reflected in the financial statements. Judgements used in making estimates have been based on the latest available, reliable information. Estimates have been revised where there are changes in the circumstances on which the original estimate was based or as a result of new information or experience.

Going Concern Basis of Accounting

10. I have assessed Angus Council's ability and the charities' ability to continue to use the going concern basis of accounting and have concluded that it is appropriate. I am not aware of any material uncertainties that may cast significant doubt on Angus Council's ability or the charities' ability to continue as a going concern.

Assets

- **11.** Where a rolling programme of asset valuations has been used, I have satisfied myself that the carrying amount of assets at 31 March 2022 does not differ materially from that which would be determined if a revaluation had been carried out at that date.
- **12.** I carried out an assessment at 31 March 2022 as to whether there is any indication that an asset may be impaired and have recognised any impairment losses identified.
- **13.** I have provided you with all information of which I am aware regarding any valuation exercises carried out after 31 March 2022.
- **14.** There are no plans or intentions that are likely to affect the carrying value or classification of the assets recognised within the financial statements.
- **15.** Owned assets are free from any lien, encumbrance or charge except as disclosed in the financial statements.
- **16.** The Common Good assets disclosed are complete based on our work to review the asset register. There have been no disposals or long term leases entered into during the year.

Liabilities

- **17.** All liabilities at 31 March 2022 of which I am aware have been recognised in the annual accounts.
- **18.** Provisions have been recognised in the financial statements for all liabilities of uncertain timing or amount at 31 March 2022 of which I am aware where the conditions specified in the 2021/22 accounting code have been met. The amount recognised as a provision is the best estimate of the expenditure likely to be required to settle the obligation at 31 March 2022. Where the effect of the time value of money is material, the amount of the provision has been discounted to the present value of the expected payments.
- **19.** Provisions recognised in previous years have been reviewed and adjusted, where appropriate, to reflect the best estimate at 31 March 2022 or to reflect material changes in the assumptions underlying the calculations of the cash flows.
- **20.** The accrual recognised in the financial statements for holiday untaken by 31 March 2022 has been estimated on a reasonable basis.
- **21.** The pension assumptions made by the actuary in the IAS 19 report for Angus Council have been considered and I confirm that they are consistent with management's own view.
- **22.** There are no plans or intentions that are likely to affect the carrying value or classification of the liabilities recognised in the financial statements.

Contingent liabilities

23. There are no significant contingent liabilities, other than those disclosed in Note 32 to the financial statements, arising either under formal agreement or through formal undertakings requiring disclosure in the accounts. All known contingent liabilities have been fully and properly disclosed, including any outstanding legal claims which have not been provided under the Code of Practice on Local Authority Accounting in the United Kingdom 2021/22 and IAS 37.

Fraud

- **24.** I have provided you with all information in relation to:
 - my assessment of the risk that the financial statements may be materially misstated because of fraud
 - any allegations of fraud or suspected fraud affecting the financial statements
 - fraud or suspected fraud that I am aware of involving management, employees who
 have a significant role in internal control, or others that could have a material effect on
 the financial statements.

Laws and Regulations

25. I have disclosed to you all known instances of non-compliance or suspected non-compliance with laws and regulations whose effects should be considered when preparing financial statements.

Related Party Transactions

26. All material transactions with related parties have been appropriately accounted for and disclosed in the financial statements in accordance with the 2021/22 accounting code. I have made available to you the identity of all the Angus Council's related parties and the charities' related parties and all the related party relationships and transactions of which I am aware.

Remuneration Report

27. The Remuneration Report has been prepared in accordance with the Local Authority Accounts (Scotland) Amendment Regulations 2014, and all required information of which I am aware has been provided to you.

Management commentary

28. I confirm that the Management Commentary has been prepared in accordance with the statutory guidance and the information is consistent with the financial statements.

Corporate Governance

- **29.** I confirm that Angus Council has undertaken a review of the system of internal control during 2021/22 to establish the extent to which it complies with proper practices set out in the Delivering Good Governance in Local Government: Framework 2016. I have disclosed to you all deficiencies in internal control identified from this review or of which I am otherwise aware.
- **30.** I confirm that the Annual Governance Statement has been prepared in accordance with the Delivering Good Governance in Local Government: Framework 2016 and the information is consistent with the financial statements. There have been no changes in the corporate governance arrangements or issues identified, since 31 March 2022, which require to be reflected.

Group Accounts

31. I have identified all the other entities in which Angus Council has a material interest and have classified and accounted for them in accordance with the 2021/22 accounting code. Any significant issues with the financial statements of group entities, including any qualified audit opinions, have been advised to you.

Common Good Fund

32. I confirm, to the best of my ability, that all material common good assets have been identified and correctly accounted for within the common good financial statements and where appropriate, common good assets in use by Angus Council have been assessed and accounted for in line with IAS 17.

Events Subsequent to the Date of the Balance Sheet

33. All events subsequent to 31 March 2022 for which the 2021/22 accounting code requires adjustment or disclosure have been adjusted or disclosed.
