PROPOSED ON-STREET PARKING AMENDMENTS CRAIGMILL GARDENS and CHAPMAN DRIVE, CARNOUSTIE

As part of ongoing monitoring of the effects on surrounding streets of the School Exclusion Zone that was implemented around Carlogie Primary School in August of 2022, we have had representations regarding congestion caused in the culs-de-sac serving numbers 58 - 96 and 37 - 63, Craigmill Gardens, during drop-off and pick-up times.

Roads officers have subsequently visited the area to observe the current on-street parking during school drop-off and pick-up times and have formulated a plan that should help alleviate this. The preferred option is attached to this public consultation.

The proposal includes the installation of a no waiting restriction round the extremity of both culs-de-sac that will ban waiting during the times that the School Exclusion Zone will be in force, Monday to Friday between the hours of 08:30-09:15 and 14:45-15:45 when the school is in session. As this may displace such vehicles to Chapman Drive which also has a footpath link to the school, we have also included that stretch that serves numbers 61 to 95 Chapman Drive in the proposals.

There will be road signs and markings necessary for the enforcement of this restriction, denoted by a single yellow line at the kerbside and yellow sign plates erected on lighting columns that will reflect the times and days this restriction will be in force, as stated above. As this is a material change to the original Experimental Traffic Order that the School Exclusion Zone trial was implemented, the objection period that covers the restriction will start again, once this new restriction comes into force, as does the on-site monitoring by Roads staff.

Please note that children will still be able to be dropped off and picked up within this restriction, the difference from the current situation is that the vehicles they alight from or are picked up by, will not however be permitted to wait for any length of time.

It should be noted however that this restriction will be applied to all road users, not just those dropping off or picking up schoolchildren, it will apply to residents and visitors to the streets as well. No permits can be issued in this respect to allow residents or visitors to wait on the single yellow line.

The restrictions will be enforced by the Council's Parking Attendants.

Your opinion is now being sought on whether or not you are in agreement with these on-street parking amendments.

Whatever your opinion, Angus Council would be obliged if you would take the time to look at the attached proposal, respond to the questions below and return it to the Council by **20 January 2023** so that your views can be taken into consideration.
