 The proposal is seeking approval for expansion of the children's residential estate, to increase current Angus Council in-house placement availability by 8 beds, over two children's houses, developed on a sequential basis over the next 3 years.

Looked After Children data returns over the last three years show an
increased use in external foster care placements and external residential
placements for children and young people from Angus being placed outside
Angus due to lack of local placements. This has budgetary effect of increasing
the unit cost of provision and reducing the overall reach of the available
resource.

 internal feedback from teams responsible for sourcing placements for children in need reflects substantial challenges identifying suitable placements locally and nationally.

- a range of research and reflection from those with lived experience supports our understanding that better outcomes can be achieved for children by retaining local family and community links and promoting safe continuity of care
- Our care experienced engagement work replicates this feedback at the local level

Findings of the Care Review resulting in the Promise Plan 2021-24 highlight the
need for children to stay locally within their own communities to support
relationships with family, peers and their wider community to improve long-term
outcomes for children. Children and families with care experience are clear
children and young people need to be cared for locally when they are not able
to be cared for at home.

- Following the relaxation of Covid restrictions, we have seen an increase in referrals for children and young people to children's social work services where there is a need for support, increased identification of children at risk and children requiring to be cared for away from home.
- the development of further internal local residential capacity is intended to reduce the likelihood of compounding these differential impacts on children and young people who are looked after, including those who have a disability and other complex needs.

## Age **Impact** - Positive

The increase in availability of placements will not be restricted by age of children but will offer the opportunity to consider the current use of two houses (Brambles) alongside two new facilities and better match the needs of young people taking account of age and stage of children.

## Disability **Impact** – Positive

The growth of our residential estate will support us to better meet the needs of children and young people, including those with a disability/ies both through the availability of additional places and the added resilience of having a wider staffing resource pool.

Although the proposal has potential to be considered positive as placements will be based on the needs of the individual young people and the placement's ability to meet those needs without discrimination based on protected characteristic of any groups.

Placements will be based on needs of individual children, no discrimination based on protected characteristic of any groups. Increased number of placements will allow

improved consideration of matching children to the right environment taking account of protected characteristics like age, sex and disability.

Increased flexibility and choice when placing children will allow for improved scope for individual needs of children to be better met taking account of sexual orientation ensuring they feel safe and protected.

- Subject to approval of the proposals, care experienced children and young
  people and families will be invited to actively participate in the project
  development, starting with the first new children's house during 2023/24. This
  will include a series of activities to capture their views so that any new home
  meets their needs. As with our approach to the design of Brambles, young
  people will contribute to detailed accommodation specifications.
- There will be engagement with relevant local communities (once identified) to support successful delivery, should the proposals be approved.
