We have carried out an options appraisal and have reviewed data from traffic counter systems (recording number of visitors) and reviewed the volume of waste collected at each recycling centre.

A review of the distance between each recycling centre has also been undertaken.

There has been no formal consultation, but more informal feedback has been received at staff forums, meetings and through direct communication on site with staff

As it has been assessed that there is no differential impact on protected characteristic groups, it was not considered necessary to do external consultation with regards equality. However, convenient access for communities has been included as an objective and has been considered as part of the options appraisal.

There are neutral impacts for all groups of customers. There will remain the same availability of accessible recycling centres, but some may have to travel a relatively short distance further. Given pedestrian access is not permitted to centres, those living in the locality of a recycling centre proposed for closure would require vehicular access no matter where a centre was located.
