## 1. APOLOGIES/SUBSTITUTES

An apology for absence was intimated on behalf of Councillor Brenda Durno, with Councillor Chris Beattie substituting.

## 2. DECLARATIONS OF INTEREST/STATEMENT OF TRANSPARENCY

Councillor Braes made a statement of transparency in relation to Item 3 (Report No 369/22) in that the applicant and his family was known to him, but not socially.

Councillor Doran made a statement of transparency in relation to Item 3 (Report No 369/22) in that prior to and following her election as a Councillor she had received numerous correspondence in relation to the application for review but that she had not given any opinion on the matter.

Councillor Fairweather made a statement of transparency in relation to Item 3 (Report No 369/22) in that the applicant had contacted him in relation to application for review and the length of time it had taken to be considered however he had passed the query to the appropriate officers.

Councillor Nicol made a statement of transparency in relation to Item 3 (Report No 369/22) in that he knew of the family.

## 3. LAND NORTH EAST OF DUNTRUNE HOUSE, DUNTRUNE

With reference to Article 4 of the minute of meeting of this Committee of 8 November 2022, there was re-submitted Report No 369/22 by the Director of Legal and Democratic Services detailing an application for a review of the decision taken by the planning authority in respect of the refusal of planning permission for erection of crematorium building and associated parking, access, turning space, landscaping and boundary enclosures, application No 20/00830/FULL, at Land North East of Duntrune House, Duntrune.

The Committee noted that an unaccompanied site visit had taken place on Monday 30 January 2023. Thereafter, the Planning Adviser provided an overview of the application for review.

(II) A COPY OF THE INFORMATION REQUIRED SHOULD BE SUBMITTED TO THE DIRECTOR OF LEGAL AND DEMOCRATIC SERVICES BY FRIDAY 17 FEBRUARY 2023, WITH A COPY TO BE PROVIDED TO THE APPLICANT AS PROVIDED FOR BY THE WRITTEN PROCEDURE NOTICE.
