1	<p>Welcome and introductory remarks by the Interim Chairperson Sandra Livingston welcomed everyone to the meeting and outlined the agenda No apologies were received</p>	
2	<p>Composition of the Community Council Sandra Livingston ran through the following:</p> <ul style="list-style-type: none"> • Maximum of 8 and minimum of 4 on the Community Council • Maximum of 3 youth members (under16s) in addition to the 8 • Co-opted members – live in the Aberlemno Community Council area and are members with voting rights • Associate members – do not need to live in the Aberlemno Community Council area and have no voting rights • Quorum is 3 for voting • Ordinary meetings – a minimum of 6 meetings per annum, members of public to be invited to attend and questions from the floor must be invited • Sandra Livingston confirmed that we should invite the local Councillors to all public meetings ie Chris Beattie, Jill Scott and Gavin Nicol (e mail addresses – cllrSURNAME@angus.gov.uk) • Once approved minutes of public meetings must be made available to the public eg through the Aberlemno.org website and must also be e mailed to Lynn ‘Hally’ at Angus Council – Sandra Livingston to provide Lynn’s e mail address • Hard copies of The Scheme of Establishment and Code of Conduct were provided • There will be an annual grant allocation of approximately £400 which is to be used only for Community Council admin purposes eg printing, venue hire etc
