Comment: Hello, can I start by saying that I am all for the community hub and it will be great for Monifieth.

However, the location to my established business is cause for concern.

On a daily basis my vans leave and return to our workshop 20+ times per day as we are a reactive maintenance company and I feel that our access will be restricted due to lack of car parking spaces proposed for the new site and therefore people will park on the road restricting our access. 4 spaces and 3 disable spaces isn't big enough for the amount of visitors you will have considering it is a library, cafe, gym and community hall.

As a construction company we have skip lorries and delivery lorries needing a large turning circle to complete the 180 degree turn into our entrance and this will be restricted with parked cars and the location of the undersized car park. The lorries cannot complete a full turn without reversing. My vans also regularly tow large trailers and require large turning circles to exit and return to the yard.

During the winter months and as I type this email the sun is low and gives what little sunshine we have onto my yard defrosting any ice and frost whilst giving us much needed daylight. The close proximity of this building will shade the whole of our yard during the winter.

Drainage: As my yard is considerably lower and susceptible to flooding due to the geography will the new build not prevent the nature land absorption of water and therefore increase the chances of us being flooded more often?

How do you propose to prevent cars blocking my access and allowing for my delivery and skip lorries safe and free access to my yard? What is the answer to the new building putting my whole yard in the shade?

As there are 40+ spaces east of the play park including electric chargers would it not be more sensible to build in this location and not impeding on 2 businesses and a family house? What plans would be in place so that my business is not interrupted during construction?
