Any certified copies of the appropriate Premises Licence may also require to be updated to reflect the details of the variation.

If you are unable to produce the Premises Licence because it has been lost, stolen, damaged or destroyed an application for a replacement Premises Licence must accompany this application, together with the appropriate fee

The fee payable in respect of the application for variation is-

- **£31** for the substitution of a new Premises Manager with immediate effect (with or without additional minor variations sought under part **2(a)**)
- **£20** for any minor variation under part **2(a)** including the substitution of a new Premises Manager which is **NOT** for immediate effect.
