The Chief Executive referred to the significant financial challenges that the Council had faced and the need over the next three to five years for the Council to transform, and that the Change Plan and Change Programme provided the strategic direction and mechanism for delivering that change. It provided the focus to support achieving a balanced budget for 2023/24 and set out the initial plans for years two and three, which would be subject to further development. She commended the report to members.
