Matters arising:

Area Updates

Finavon: Roadworks, namely resurfacing are taking place in Finavon at the Tannadice junction

Tannadice: A fence at the side of the park has rotted and is believed to be dangerous. Cllr Beattie to take forward.

Concern was again raised about farm vehicles travelling through Tannadice, and a problem with the school traffic lights was picked up by Cllr Bell.

Glen Prosen: Work on the Spott Bridge in Glen Prosen is still outstanding. Work is taking place on potholes (some very deep) throughout the Glen.

Memus: The children at Burnside Farm have become accustomed to the arrangements for pickup with school transport.

Justinhaugh: A dyke has washed away after period of heavy rain and floods. Ivan reported that there are now 3 islands in the river with gravel build-up and as a result it id likely the road is being undermined

community buyout, but this requires a lot of research as the hill and the monument are owned by Airlie Estates. Cllr Bell to speak to the Dangerous Buildings Officer.
