Action points

E.Walker Munro has been in touch with Tayside Contracts with regards to perhaps getting help with problem which have been highlighted as requiring attention. R.Finlay has highlighted the problems needing attention. E.Walker Munro has filled in and returned the appropriate form and is now waiting a reply.

With regards to the possibility of a public meeting to discuss what the village wants or needs as a resilience plan as yet no date has been arranged. R.Finlay is in communication with N.McLeod .

Matters arising from meeting on 20th February:

The subject of IT equipment was raised again. It was proposed that as the chair of the Community Council was absent this subject should be put on the agenda for the next meeting and the council agreed.

With regards to the speeding issue. Apparently if a complaint is received the Council do check the actual speeds and if the case is proven they pass the complaint to Police Scotland who then decide a course of action. A discussion ensued as to how to combat speeding through the village. A suggestion was put forward that instead of a 40mph sign followed closely by a 20mph sign, The 40mph sign should be removed so there is only a 20mph sign as it was felt that the 20mph sign is missed by drivers. It was suggested that the cost of a pop up policeman should be investigated and brought to the Council at the next meeting.

Action pt: C.Jackson is to send a formal request to Angus Council for this suggestion to be considered

The subject of play equipment was raised again. Apparently the area originally suggested for the equipment is now being used by the school for sports. This subject now needs further investigation and discussion before a decision can be made therefore it is still a work in progress.

Action pt: R.Finlay is to fill in an application form for funding from the Windfarm Trust

Action pt: R.Finlay is to check up on expenses with regards to the joinery work undertaken for storage.
