A range of consultation has been carried out which ensures this is a co-produced plan which limits risk. The Council Plan outlines what Angus Council can deliver given the current financial constraints being faced not just in Angus but across Scotland.

There will inevitably be negative impacts arising as the Council strives to balance its budget while meeting its statutory obligations. It is not possible to deliver the scale of savings required without negatively impacting on the scale and scope of Council services but the Council will strive to ensure that these negative impacts are minimised and each individual EIA will assess the potential negative implications of saving proposals.

# Step 13(A) What evidence do you have about any socio-economic disadvantage/inequalities of outcome in relation to this strategic issue?

As part of the plan we have identified a series of indicators to monitor progress and give a baseline to local challenges. The new indicators and targets in the plan will be reviewed regularly and ensure that services are reactive to local need.

- Child poverty can undermine the health, wellbeing and educational attainment of the children who experience it. A 2013 study found that child poverty in the UK was costing at least £29 billion a year.
- Scottish Government Equity Audit / CPAG Cost of the School Day / Rowntree Reports.
- Data for the period 2021/22 highlights a 3.6%increase in children living in poverty in Angus from 2020/21. It is estimated there are around 3,500 households impacted by poverty affecting approx. 5,000-6,000 children. There have been increases in, unemployment with claimant count at 2,150 (3.1%) in April 23, up from a low of 1,870 (2.7%) in Sep 22.
- The Scottish Government's current programme of building 50,000 affordable homes with 35,000 for social rents is a direct response to tackle poverty. In Angus the new Housing Strategy aims to support local people and puts poverty at the heart of key actions.
- The most recent Scottish Government poverty statistics show 250,000 children (24% of all children) were still living in poverty in Scotland in the period 2019 to 2022. Children remain at significantly higher risk of poverty than pensioners (15%) and working age adults (21%). The figures show levels of child poverty broadly stable in Scotland, but pre-date the full roll out of the Scottish child payment.

#### <u>Impact</u>

Neutral Impact – despite the context of our financial challenges which will restrict our service ambitions in places, there will continue to be a drive to achieve a positive impact on those with low or no wealth as we will continue to deliver interventions to maximise

income through employability programmes and business support as well as support children and families through e.g., free school meals, decrease numbers of homeless.

**Material Deprivation** (i.e., those unable to access basic goods and services e.g., repair/replace broken electrical goods, warm home, leisure and hobbies).

### **Impact**

Neutral Impact – despite the context of our financial challenges which will restrict our service ambitions in places, we will strive to achieve a positive impact on those with material deprivation as we will continue to support interventions to maximise income through support with social security benefits and access to services.

**Area Deprivation** (i.e., where people live (e.g., rural areas), or where they work (e.g., accessibility of transport).

### **Impact**

Neutral impact – despite the context of our financial challenges which will restrict our service ambitions in places, there will continue to be focus on improving access to services, although this may not always be through Council interventions but through partnership working and community wealth building. An example of this has been seen with the Cost-of-Living Roadshows.

**Socio-economic Background** i.e., social class including parents' education, people's employment and income.

### **Impact**

Neutral Impact – despite the context of our financial challenges which will restrict our service ambitions in places, we will strive to achieve a positive impact on those who are deprived due to their background, as we will continue to include interventions to maximise income through the drivers of poverty, specifically around increasing income from employment, social security benefits and in kind.
