

At 4.2 Report 172/24 states 'support the different needs of our customers' At the moment the Restenneth facility is open for longer hours than Arbroath Library. To support customers of the archives, the Library needs to be open the same hours as present at Restenneth. Please confirm this is so - there is no mention of it in 172/24. Whilst the curent opening times at Restenneth are slightly different from those at Arbroath Library, opening times are constantly under review to ensure these remain appropriate in terms of the provision of public services. 

It is equally accessible. How accessible was the Hunter Library at Restenneth? Why the need for further costly change at Arbroath Library??	Engage Angus		Arbroath Library works had already been agreed and building options were considered. A permanent move to Saltire would require considerable investment and result in a loss of activity space which could also impact the existing relationship with Dundee and Angus College. The main costs for the Archives relates to relocation costs. The access issues relate not to the building but to getting there, there is no pedestrian routes leading to Hunter Library and no public transport links, the only real option is to take your own transport.
Why has serious consideration been given to utilising Edzell Inglis Memorial Hall as an archive base. It is a wonderful historic building with it's own library and cultural area and the main hall area could be used to house all the historic items form over Angus. It has been handed back form Angus Alive to the Council so better to use that sit with sporadic use but still requiring maintenance and running costs. The building is currently subject to ongoing investigations relating to continuing its operation within the community - with a view to returning it to active public use in the future. Angus Council are looking to reduce its estate, hence movement to an existing operational building. Restenneth lease expires at end Feb 2025.

Comment Form		Building costs have previously been agreed and in the main do not relate to relocation of the Archives. The savings only relate to rental, no account is given to potential future maintenance costs of the Hunter Library. All existing Council buildings were considered as part of an earlier exercise.
To spend £290k to save £10k Pa running costs at Restenneth does not seem prudent. To move local history from local libraries to Arbroath is a retrograde step. Anyone going research on local history needs to browse the references available on the library shelves, not as suggested in the proposal, order a book to be sent from Arbroath. Why not be more honest and call it Arbroath Archives instead.?
