**What is being proposed?**Community resilience funding scheme to be established and delivered in 24/25. The scheme outcomes are to ensure capacity is developed in local communities to address emergency situations and Increased individual and community resilience to respond to emergency situations.

This is a new proposal that will provide funding to constituted Community Resilience Groups who are based and deliver in the localities of Angus. The groups will be required to meet criteria of the fund and report on impact against outcomes. The funding can be used to support the following-

Community information and promotion of community resilience. Volunteer support. Purchase of equipment to support emergency response.

Public liability insurance.

The long term aim is to strengthen and build capacity in local groups so they can be self sustaining in the future.

This is a new project and will be supported by partnership of internal from external organisations. The funding is comprised of external funding for 24/25.

Impact

The community resilience fund development relates to a wide range of weather and emergency events. In the past year the focus has been around flooding given the impact of Storms in autumn 2023.

Across Angus, over 500 properties and 52 businesses were impacted across a wide geographical area including: Strathmartine, Bridgefoot, Liff, Monifieth, Eassie, Newtyle, Finavon, Tannadice, Brechin, Edzell, Easthaven, Inchbare, Kinnaird, Arrats' Mill and Bridge of Dun, Logie Mill and Craigo.

Since Storm Babet, 3 further storms have impacted Angus and specifically Storm Gerrit on 27 December 2023, causing further damage to roads and infrastructure.
