- 1. The person responsible for piloting the vessel at sea will require to produce a Boatman’s Licence as proof of his/her ability to handle the vessel. Applications for such a Licence should be made, in writing, to the Department of Trade, Marine Office, Blaikies Quay, Aberdeen (telephone 01224 574122). The application will not be processed without payment of the appropriate fee.**
- 2. Any person who is, or in connection with, the making of this application makes any statement which he knows to be false or reckless makes any statement which is false in a material particular shall be guilty of an offence and liable, on summary conviction, to a fine not exceeding £2,500.**
