MINUTE of SPECIAL HYBRID MEETING of **ANGUS COUNCIL** held in the Town and County Hall, Forfar on Thursday 8 May 2025 at 2.00pm.

1. INTERIM CHAIR OF THE MEETING

The Chief Executive, Kathryn Lindsay chaired the meeting and welcomed all members.

At this stage in the meeting, Councillor Proctor MBE, Veterans Champion spoke to commemorate the 80th anniversary of VE Day. He began by reminding those present that Prime Minister Winston Churchill announced that one minute past midnight on Tuesday 8 May 1945 would be known as Victory in Europe Day (VE Day).

He stated that we should never forget those who fought during World War II. Many of the service men and women did not return and the loss of lives is replicated throughout every town, village and settlement throughout Angus and the rest of Great Britain and Northern Ireland.

He concluded with an epitaph which was penned over 80 years ago and which he felt was still as pertinent today as it was then as British service personnel still put their lives on the line in today's very troubled and unstable world.

2. APOLOGIES FOR ABSENCE

There were no apologies were intimated.

3. DECLARATIONS OF INTEREST AND STATEMENTS OF TRANSPARENCY

Councillors Doran, Fotheringham, Melville and Whiteside each made a statement of transparency in relation to Items 7 and 8, Report Number 129/25, in that they were ward members of Monifieth & Sidlaw and had had interactions with constituents and tenants who may be affected.

Councillor Speed made a statement of transparency in relation to Item 10, Report Number 131/25, in that she had been an IJB Member previously and that family members receive health and social care support.

Councillor Scott made a statement of transparency in relation to Items 7 and 8, Report Number 129/25, in that she had been contacted by the Dundee RAAC Action Group who were representing Angus residents.

4. ELECTION OF PROVOST

The Chief Executive called for nominations for Provost of Angus.

Councillor Meechan, seconded by Councillor Wann, moved that Councillor Fotheringham be appointed Provost of Angus.

Councillor Duff, seconded by Councillor McDonald, moved that Councillor Cheape be appointed Provost of Angus.

The meeting re-convened at 2.34pm.

The Provost took the opportunity to thank Councillor Clark. He acknowledged her strong commitment and dedication to the role of Provost, Depute Provost and Ward Councillor and praised Councillor Clark for her professionalism, enthusiasm and friendliness and for being an excellent ambassador for Angus.

5. ELECTION OF DEPUTE PROVOST

The Provost called for nominations for Depute Provost of Angus.

Deputation Request

The Provost intimated that a deputation request had been received from Mr Chowdry in relation to Report No 129/25 – Options Appraisal – Works to Angus Council Homes Featuring Reinforced Autoclaved Aerated Concrete in Milton Street, Monifieth.

The Council resolved to hear the deputation immediately prior to consideration of Item 7.

At this stage in the meeting, the Provost advised that members had been provided with an Addendum to Report No 133/25 which referenced further information in relation to the appointments to Outside Bodies. The Addendum had not been published within the required "3 clear days" by reason of special circumstance however, the Provost had determined that in accordance with the provisions of Standing Order 10(2)(ii) the item could be considered at this meeting as a matter of urgency to allow the appointments to Outside Bodies to be made at this meeting.

6. EXCLUSION OF PUBLIC AND PRESS

The Council resolved, in terms of Standing Order 27(2), that the public and press be excluded during consideration of Items 8-10 so as to avoid the disclosure of information which was exempt in terms of Part 1 of Schedule 7A to the Local Government (Scotland) Act 1973, Paragraphs 4, 6, 8 and 9.

As this stage in the meeting, and prior to consideration of Report No 129/25, Mr Chowdry addressed the Council in relation to the Options Appraisal - Works to Angus Council Homes Featuring Reinforced Autoclaved Aerated Concrete in Milton Street, Monifieth. He asked the Council to expand the scope of RAAC remediation planning to include the 49 private homeowners in Milton Street and any others identified through further investigation; to seek immediate funding from the Scottish and UK Governments; use the Scheme of Assistance to offer grants, missed share options, or sundry debt recovery loans for private owners especially those on low incomes or in shared roofs; to release costings for proposed works to the public to ensure transparency, allow informed resident decisions, and build community trust; to provide clear written timelines to all affected residents, council tenants and private owners alike and to maintain open communication channels; to hold a follow-up public meeting with all Milton Street residents before any final decision is taken; and to investigate RAAC in other Angus homes, especially properties built privately in the 1950s-80s, and consider what support could be provided to homeowners caught unaware.

There being no questions from members, the Provost thanked Mr Chowdry for his presentation.

7. OPTIONS APPRAISAL - WORKS TO ANGUS COUNCIL HOMES FEATURING REINFORCED AUTOCLAVED AERATED CONCRETE (RAAC) IN MILTON STREET, MONIFIETH

There was submitted Report No 129/25 by the Director of Infrastructure and Environment outlining options to allow members to consider the optimal method for addressing Reinforced Aerated Autoclaved Concrete panels (RAAC) within 25 homes in its social rented housing stock in Milton Street in Monifieth. The Report also outlined the implications and potential next steps.

The Report indicated that following guidance issued by IstructE in April 2023, Angus Council had commissioned Dundee City Council's Principal Engineer to carry out surveys of the 26 council owned properties in Milton Street, Monifieth, where it was suspected that the construction may include RAAC panels. The surveys comprised of visual inspections and non-intrusive investigations in accordance with advice contained in published IStructE guidance. RAAC was identified in 25 of the 26 homes owned by Angus Council, the other was found to have no RAAC and a timber roof construction.

An options appraisal was carried out on a range of options, which were assessed against a number of criteria using an options appraisal format. Full details and results were attached within Appendix 1 to the Report. Option 4 'Remove RAAC – Install a new Flat Roof with Timber Structure' scored significantly higher than the other options. This would completely remove the risks associated with RAAC and create a new roof insulated to current standards and with a new finish which could last for c.40 years. Progressing with option 4 was assessed as preferable, and would require interaction and engagement with a number of owners of neighbouring properties which adjoin Angus Council properties. This had informed the development of the proposed next step which would be to commence engagement with affected private owners. The approach to engagement would prioritise clear communication, individual engagement, and a solution-focused strategy to ensure all parties were informed and supported.

Following a number of questions and comments from members, the Council resolved:-

- to note the Options Appraisal set out in Appendix 1 to the Report (Exempt) and that the preferred option was to remove RAAC panels and to install new flat roofs (Option 4);
- (ii) to delegate authority to the Director of Infrastructure and Environment, and his nominated representatives, to engage with tenants and owners of impacted properties regarding the results of the options appraisal and the feasibility of the preferred option to remove RAAC panels and to install new flat roofs; and
- (iii) that a further report be brought to the Housing Committee, outlining and seeking approval for the recommended next steps following the engagement with tenants and owners in the Milton Street area.

8. OPTIONS APPRAISAL - WORKS TO ANGUS COUNCIL HOMES FEATURING REINFORCED AUTOCLAVED AERATED CONCRETE (RAAC) IN MILTON STREET, MONIFIETH

There was submitted and noted Exempt Appendix to Report No 129/25 by the Director of Infrastructure and Environment.

9. OPTIONS APPRAISAL - DELIVERY OF CONTRACTS FOR A HOUSING REPAIRS SERVICE FOR ANGUS COUNCIL'S SOCIAL RENTED HOUSING STOCK FROM APRIL 2026

There was submitted Report No 130/25 by the Director of Infrastructure and Environment outlining options to allow members to determine the best approach for procuring and awarding contracts for the delivery of a Housing Repairs and Voids service for its Social Housing from April 2026.

Following a number of questions and comments from members, the Council resolved to approve the recommendations, as detailed in the Report.

At this stage in the meeting, the Council resolved to adjourn for 15 minutes.

The meeting re-convened at 4.02pm.

10. ADULT SOCIAL CARE – EMPLOYERS NATIONAL INSURANCE CONTRIBUTIONS

There was submitted Report No 131/25 by the Chief Integration Officer detailing the proposed approach to supporting Adult Social Care Home Care providers manage the implications of the changes to Employers National Insurance Contributions in the context of the wider impact of Employers National Insurance Contributions in Adult Social Care.

- this role includes a fee payable by the Park Authority and is in addition to the councillor salary paid by Angus Council. The latest published fee levels are £239.67/day and an assumed time commitment of 36 days p.a. which would mean payment of £8,628.

Financial Implications

The proposed structure and the costs arising are in compliance with the Remuneration Regulations.

Employers costs for national insurance and pension contributions will be payable in addition to the total cost shown of £835,185. Actual pension costs will however depend on how many elected members choose to be members of the pension scheme (all elected members under 75 are auto-enrolled in the scheme but can opt out). The budget provision of £1.037 million will be sufficient to meet all costs including employers costs arising from the structure shown above.

- (iv) agrees to delegate authority to the Director of Finance to apply any non-material changes to the remuneration structure following consultation with both the Leader of the Council and the Leader of / Spokesperson for the Non-Administration / Opposition;
- (v) notes that opportunities for further reform of Committee and remuneration arrangements can be considered in due course if required.

The Council resolved to have a 5 minute adjournment to allow members the opportunity to consider the terms of the motion.

The meeting re-convened at 8.22pm.

Councillor Speed sought clarity in relation to the remuneration, and in particular her salary. The Director of Finance noted that Councillor Speed had elected not be paid the full salary and that this would be reflected in the remuneration structure.
