4. APPOINTMENT OF AN EXECUTIVE SUB-COMMITTEE

Reference is made to the Special meeting of Angus Council held on 22 April when all political appointments, including those appointed to Sub-Committees, became vacant. Following the subsequent Special meeting of Angus Council on 8 May 2025, where appointments to Standing Committees were agreed, the Housing Committee is now required, as per the Council's Scheme of Governance, to appoint an Executive Sub-Committee to act with full delegated powers.

Standing Order 32 provides that each Standing Committee will appoint an Executive Sub-Committee to 'decide any matter (other than a matter affecting Council policy):-

- (i) which would normally be decided by the Standing Committee but which, by reason of its urgency, requires to be decided upon during the annual recess or,
- (ii) which has been specifically delegated to the Executive Sub-Committee by the Standing Committee.'

Composition: The Sub-Committee comprises three elected members of the Committee who are entitled to appoint substitute elected members (who need not be members of the Housing Committee). All three persons must be present to form a quorum. In appointing members to Sub-Committees, the Committee shall, so far as possible, give effect to the principles regarding political balance as set out in Standing Order 33.

The Committee is asked to:-

- (i) to appoint three members to the Sub-Committee, and to appoint a Convener ad Vice-Convener of the Sub-Committee; and
- (ii) to note the remit of the Sub-Committee is as detailed above.
